#### A FRIENDLY REMINDER ABOUT YARD SIGNS

Our architectural rules are specific regarding yard signage. Some contractors are advertising with signs in the front yard of homes. Homeowners are reminded this is against association rules.

- 1. No "For Sale" signs on vehicles are permitted.
- 2. No construction signs of any kind, are permitted during or after the completion of a project.
- 3. Removal of political signs is required ONE WEEK after an election. All other signs require architectural approval.

Many of you may be aware of the giant oak tree that is on our hill, next to Triunfo Canyon Road, between Glastonbury and Highgate. This oak is several hundred years old.
