ANNUAL BUDGET AND DUES UPDATE

LANDSCAPE UPDATE



As we wait for the City of Thousand Oaks to schedule a date to remove the pine trees in the Highgate street medians for replanting with new trees, we are reviewing new plantings with a professional landscaper to greatly improvement the appearance of the medians and monument areas. As a huge bonus, the City has informed us they will remove the pine trees and replant with new trees, as well as repair the planters and damaged street areas at City cost, saving our community tens of thousands of dollars.

We have also placed a request with the City to re-surface our streets. So, sometime after the tree work and plantings are finished in the medians, the City will let us know when we can expect our streets to be done.

SOUTHSHORE HILLS GOVERNING DOCUMENTS

We are finalizing the updates and restating of our governing documents (Codes, Covenants, & Restrictions, amendments, and By-Laws) to conform with all of the new laws since their original drafting. With the assistance of legal counsel, we should have a draft of these available to the community for review sometime in December.



We are also looking into hosting a holiday themed, socially distanced townhall in January as well, to discuss the updated CC&Rs. However, depending on COVID restrictions at that time, we may have to adjust plans and will keep you posted.

NEIGHBORHOOD SAFETY
